The Town Board meeting is held at 6:00 p.m. on the second Wednesday of each month.

Board of Review is set for Saturday, June 1, 2019 from 10 a.m.- 12 noon.

Town Clean-Up Day is Saturday, September 7, 2019 between 8 a.m. – 3 p.m. Please see the Spooner Advocate ad for what will be accepted.

Snow Plowing and Road Maintenance- is performed by Norton Excavating. All concerns involving snow plowing or road maintenance should be addressed to the Casey Town Board at the monthly meeting and NOT to Norton Excavating. If you wish to hire them to do your driveway you can find their phone number in the yellow pages.

Driveway and building permits- An approved Town driveway permit must be submitted to the Washburn County Zoning Office when applying for building permits. Driveway permit applications can be obtained on our website or from the Casey Town Clerk Corinne Slabaugh, (715) 635-7580. Assisting us with this process the County Zoning Office will not issue any building/sanitary permits unless a completed and approved Town driveway permit is presented. Fireworks Usage for the summer of 2019- Wisconsin statutes require a permit for use of all non-handheld fireworks and will be issued through June 28, 2019 by Casey Town Board Chairperson: Tom Mackie (715) 635-3656; W9065 Lower McKenzie Rd., Spooner, WI 54801. **Valid only if burning conditions warrant.** The permit allows detonation between the hours of 9 p.m. and midnight from July 3rd through July 6th, 2019. *A separate application and permit must be obtained for each day of fireworks usage.* Please check our website for information and permit applications.

The Town Treasurer reminder- State Lottery Credit on property taxes must be on a permanent residence as of January 1st of any year to qualify. Go to The Washburn County Treasurer to fill out forms or ask questions.

Tentative Road Construction- Please watch meeting minutes for updates. The summer of 2019 plans include the paving of Island Lake Rd. construction area, Casey Lake Landing Rd., Little Bass Lake Rd. landing area, and two large culvert replacements.

Continue to be aware- Zebra mussels have been found in Big McKenzie Lake!! **PLEASE** clean all boats and water toys before using another body of water. If there is a decontamination station at a landing it **MUST** be used by LAW.

Reminder for ATV usage- ATV's are allowed on marked roads in the Town of Casey.
